COMMUNITY APPEARANCE

Observations:

Streets, parks, and the waterfront area were clean and visually appealing, clearly reflecting the pride citizens take in their city. We even observed residents picking up litter as they walked, a testament to the community's commitment to keeping North Bay beautiful. Clean, Green, Beautiful North Bay (CGB) supports these efforts by providing garbage cleanup kits to organizations and residents, and there are many examples on social media of citizens using these kits. Congratulations on fostering such a strong sense of ownership and pride throughout the community.



In 2025, the city approved additional staffing to strengthen litter and graffiti management, with a particular focus on the downtown core. Issues are tracked through a GIS application, allowing for data-driven identification of hotspots. North Bay also offers a graffiti and litter reporting system on its website, making it easy for citizens to participate. The City and CGB actively encourage community reporting and support prompt removal efforts. Public art installations by local artists are used effectively to deter vandalism and celebrate North Bay's culture — a creative and inspiring approach. Volunteer groups are also working closely with downtown businesses to enhance landscaping and encourage business owners to take pride in maintaining their storefronts. This collaboration has noticeably improved the appearance of the downtown core and fostered a shared sense of responsibility.

That spirit of pride and volunteerism is contagious and visible everywhere — from the heritage gardeners tending the display beds, to the friendly greeters at the Heritage Carousels, to the service club ambassadors welcoming visitors at the Non-Profit Fair. The same attention to detail can be seen in parks and playgrounds, which are clean, safe, and inviting, and in schoolyards and sports fields, which are well-kept and reflect student involvement. Consistent street lighting and attractive seasonal banners create a welcoming streetscape, while coordinated waste and recycling receptacles placed throughout public areas help promote tidiness and environmental responsibility. The waterfront park and historical and commemorative sites are enhanced by clear, well-maintained signage, making them accessible and informative to visitors.

The Streetscapes Program, which recognizes both residents and businesses for their exceptional gardens and greenery, is another standout initiative that celebrates community pride and beautification efforts. Well done, North Bay!

Recommendations:

Three of the five gateway signs have been installed, and the city is continuing its work to enhance the signage with plantings. We encourage you to keep up this effort and complete the gateway signage program, as these entrances provide an important first impression for visitors.

Outside the downtown core, there are some areas that could benefit from enhanced curb appeal. Consider encouraging businesses, institutions, and residents to beautify these spaces with plantings, container gardens, public art, or other creative



features that reflect community pride and make these areas more inviting.



The City's use of steam foam for weed management along sidewalks is a sustainable approach, and while weeds are being controlled, additional attention in some areas would help elevate overall appearance. City staff responsible for sidewalk maintenance, pothole repairs, street sweeping, and similar tasks could be engaged to "audit" the areas they service, noting locations in need of improvement. There is also an opportunity for Clean, Green, Beautiful North Bay (CGB) volunteers to review hardscaped areas and provide feedback to the city to help prioritize areas requiring attention.

During the tour, a few residential properties were observed that appeared unkept. With the addition of a dedicated Property Standards Officer, enforcement of the Clean Yard By-law should continue to be a priority to maintain a consistent standard across all neighbourhoods.

To further address graffiti issues, consider expanding your initiatives to include opportunities that teach young graffiti writers and street artists how to express their creativity in respectful, community-supported ways. This could involve inviting experienced muralists and graffiti artists to lead workshops, mentor youth, and demonstrate how street art can be used to tell meaningful stories. Hosting public painting sessions, providing designated spaces for artwork, and developing seasonal themes with rotating displays would give artists a platform to showcase their talents while



respecting public spaces. Celebrating these works through community unveilings would help shift graffiti from an act of defiance to a source of community pride.

ENVIRONMENTAL ACTION

Observations:

North Bay has implemented an impressive range of waste reduction initiatives that reflect its strong commitment to sustainability. Programs such as Goods Exchange Day, which allows residents to place unwanted items at the curb for others to take, and textile recycling through Canadore College are helping divert materials from the landfill. The city also engages elementary students through creative public education artwork that teaches the "6 R's" (Reduce, Reuse, Recycle, Rethink, Refuse, Repair), helping instill lifelong environmental habits at an early age. The "Our Arenas Are Your Arenas" recycling campaign and the addition of numerous recycling



containers in the downtown core further encourage responsible waste management. These combined efforts have resulted in a significant reduction in annual waste tonnage, an accomplishment worth celebrating.

Water conservation has also been enhanced through the implementation of water meters, which have successfully reduced consumption despite the City's abundant water resources.

Energy innovation is another area where North Bay shines. The Merrick Landfill power generation facility and a number of alternate energy projects led by local institutions and businesses demonstrate a strong commitment to efficiency and sustainability. A standout example is North Bay Hydro's Community Energy Park, a state-of-the-art microgrid that combines solar panels, combined heat and power generation, and battery storage. This system can operate on the main grid or independently during outages, providing uninterrupted power to key facilities such as Memorial Gardens and the YMCA, which serve as critical gathering points for residents during emergencies. This innovative project not only strengthens local energy resilience but also reduces greenhouse gas emissions, advances sustainability goals, and serves as a model for other communities seeking to enhance energy security.

Congratulations to the City of North Bay, its institutions, and businesses for their leadership in environmental stewardship and energy innovation.

Recommendations:

We encourage the City to continue using data to measure and share its progress in waste reduction. Tracking metrics such as kilograms of waste per person and other key performance indicators, benchmarking against similar communities, and reporting results publicly will help maintain momentum and celebrate achievements with residents.

There is an opportunity to expand recycling efforts by placing recycling stations in public areas beyond the downtown core, including parks, sports fields, and other high-traffic community spaces. This would make recycling even more accessible to residents and visitors.

The North Bay Farmers' Market, a cornerstone of the community, could be a strong partner in advancing sustainability. Collaborating with market organizers to explore a reusable or returnable food packaging program would significantly reduce single-use waste and further position the market as a leader in environmental responsibility. Establishing a station where residents can donate clean, gently used shopping bags for a community bag-sharing program would make it easier for shoppers to reduce single-use plastic and support a culture of reuse.

Water conservation efforts could be strengthened by introducing residential programs that reduce potable water use, such as subsidized rain barrels, workshops on rainwater harvesting, and incentives for permeable paving or xeriscaping in private landscapes.

We also recommend prioritizing the development of a comprehensive Climate Action Plan. Such a plan could address stormwater management through green infrastructure, set targets for water, energy, and emissions reduction, and engage businesses, institutions, and residents in adopting strategies that support sustainability and climate resilience.

Finally, the city could expand public education campaigns to include backyard composting, food waste reduction, and urban gardening initiatives, which would help keep organics out of the landfill while engaging residents in hands-on sustainability efforts. Establishing a sustainability recognition program to celebrate businesses, institutions, and neighbourhoods that excel in waste diversion, water conservation, and energy reduction would further inspire participation and strengthen the culture of environmental stewardship across the community.

HERITAGE CONSERVATION

Heritage conservation includes efforts to preserve and protect both natural and cultural heritage within the community. Preservation of natural heritage pertains to policies, plans and actions concerning all elements of biodiversity including flora and fauna ecosystems and associated geological structures and formations. Cultural conservation represents the "persona" of a community and refers to the heritage that helps define the community including the legacy of tangible (built/hard assets) elements such as heritage buildings, monuments, memorials, cemeteries, artifacts, museums and intangible elements such as traditions, customs, festivals and celebrations. The participation of groups such as historical societies, traditional cultural groups, and conservation groups is considered.

HERITAGE CONSERVATION

Observations:

North Bay's approach to heritage is rooted in community engagement and respect for its cultural and natural assets. Heritage designation is offered through an application process, with the city encouraging property owners seeking building permits to apply and providing support throughout the process. While recommendations for heritage preservation are not mandatory, the city actively promotes best practices to help maintain the character of historic properties.



The community takes great pride in its natural and cultural heritage. Laurier Woods and other significant natural areas are stewarded by dedicated

volunteer organizations, reflecting strong public participation in heritage conservation. North Bay's centennial celebrations in 2025 are further amplifying this pride, with the city providing approximately \$200K in grants to volunteer organizations to enhance community-led events — a wonderful way to mark this milestone year.



A standout example of North Bay's heritage celebration is the beloved Heritage Railway and Carousel, which captures the spirit of creativity and collaboration. The original Heritage Carousel and the Winter Wonderland Carousel, featuring 16 hand-carved Northern Ontario wildlife figures by local artisans, showcase community talent and imagination. A sponsorship program helped fund their construction, connecting local families and businesses to the project. Operated and maintained entirely by volunteers,

the carousels and miniature Heritage Railway have become symbols of local pride and joy, delighting residents and visitors year after year.

North Bay is also committed to inclusion, diversity, and reconciliation. The city works closely with Indigenous partners to honour the Truth and Reconciliation Commission's Calls to Action, with initiatives such as Suswin Village — a housing program offering cultural, mental health, and addiction supports through the North Bay Indigenous Friendship Centre. The waterfront reflects this spirit of respect and acknowledgement, featuring Zhaabgizhick Beach, named in honour of Chief Michel Zhaabgiizhik of the Nbisiing Nishnaabeg, Ojibway, and Algonquin peoples. The Chief Commanda II cruiser and surrounding spaces serve as welcoming gathering places, celebrating both the city's history and its presentday vibrancy.



Together with its many non-profits and service clubs, which support 2SLGBTQI+ individuals, underprivileged families, hospice care, and cultural initiatives, North Bay continues to strengthen its identity as a community where heritage, inclusion, and a sense of belonging thrive.

Recommendations:

There is an excellent opportunity for North Bay to strengthen its Heritage Plan by more explicitly recognizing and protecting natural heritage assets such as Laurier Woods, waterfront parks, and trails. Adding educational signage, guided walks, and interpretive programming would highlight these spaces for both residents and visitors while reinforcing the value of conservation.

We recommend developing by-laws as part of the Heritage Plan that grant the city the authority to protect both natural and cultural heritage assets. This would ensure long-term stewardship of key sites, including historic buildings, landmarks, and landscapes, while giving future generations the chance to enjoy them.

Properties that have applied for heritage designation currently receive a glass plaque, but those observed were often difficult to read and not fully consistent with the heritage aesthetic. Consider exploring alternative plaque materials such as stone, brass, or even locally sourced wood — a nod to North Bay's forestry heritage — to create a

more durable, attractive, and legible marker.



The city could also celebrate its centennial legacy by expanding digital storytelling efforts, such as an online interactive map of designated heritage sites, oral history projects, or QR codes at significant locations that link to historical information, photos, and videos. This would engage younger audiences and bring history to life in a modern, accessible way.

The North Bay Sports Hall of Fame, located in the Boart Longyear Memorial Gardens, celebrates the city's proud athletic history. Its displays honour local athletes, coaches, and builders who have made lasting contributions to sports in the community. Preserving and sharing these stories is vital to keeping North Bay's sports heritage alive. Digitizing records and memorabilia, in partnership with schools, libraries, and local media, would make this history more accessible, inspire future generations, and ensure these achievements are never forgotten.

Finally, there is an opportunity to partner with schools, service clubs, and Indigenous partners to create youth-led heritage initiatives, such as student-curated exhibits, heritage art projects, or volunteer opportunities at cultural events. This would foster a deeper appreciation for local history while inspiring the next generation to take pride in preserving North Bay's heritage.

TREE MANAGEMENT

TREE MANAGEMENT

Observations:

North Bay's impressive 44% tree canopy is one of its defining features, giving the city a lush, green character and contributing to the health and well-being of residents. Congratulations on achieving and maintaining such a vibrant urban forest. To ensure this canopy is sustained for future generations, the city is developing a Tree Canopy Plan that will include recommended species lists and guidelines for both public and private properties.

The city's commitment to tree planting is strongly supported by community partners and volunteer groups. Local schools have been key participants, with 5-6 schools establishing small orchards where students are actively involved in planting, adopting, and caring for trees. These orchards have become living classrooms, integrating environmental education into the curriculum and fostering stewardship at a young age. Canadore College partners with Clean, Green, Beautiful North Bay to plant trees at schools, further strengthening this educational connection.

North Bay Hydro's Right Tree, Right Place program is an excellent example of corporate responsibility. Through this initiative, they have donated 100 trees and 2,000 saplings and helped plant trees in schoolyards across the community. 22 Wing Base also contributes by following a two-to-one replacement policy for tree planting, reinforcing the importance of maintaining and increasing the urban canopy.

The volunteer-run tree starter nursery, established in 2006, continues to be a best practice and a model of long-term sustainability. This initiative not only supplies trees for community planting efforts but also demonstrates the power of citizen involvement in shaping the local landscape.

Together, these efforts have created a thriving urban forest that contributes to climate resilience, improves air quality, reduces stormwater runoff, and enhances the beauty of streets, parks, and neighbourhoods throughout North Bay.



Recommendations:

As North Bay advances its Tree Canopy Plan, we encourage the inclusion of a strong educational component for residents, businesses, and institutions. Providing guidance on the selection of appropriate native trees and shrubs, as well as effective planting and maintenance techniques, will help ensure long-term canopy health and survival rates. Workshops, demonstration sites, and online resources could further support this learning.

Businesses and residents can be more deeply engaged by celebrating National Forest Week with treethemed events, guided walks, and educational activities. A tree giveaway program—where participants can choose from a variety of native species—could encourage planting on private property. Charging a nominal fee or requiring a registration process could enhance accountability for the care of the trees and promote a sense of stewardship.



There is an opportunity to protect and celebrate the giant Eastern cottonwood located at the easement by Chippewa Creek west of Duke Street East. Surveying and researching its history, installing interpretive signage, and creating a small storytelling or gathering space nearby could transform this natural asset into a celebrated landmark, connecting residents to the city's ecological and cultural heritage.

During the tour, it was noted that many shopping plazas have large, paved parking areas with little or no tree coverage. Introducing tree islands and setting green coverage requirements for new developments would help reduce heat island effects, improve stormwater management, provide shade for vehicles and pedestrians, and enhance the visual appeal of commercial

areas. Similarly, while bioswales were observed at Laurentian Ski Hill's turning bay, incorporating more shade trees into the parking lot would further improve environmental performance and visitor comfort.

Finally, consider developing an urban tree inventory and canopy monitoring program to track planting efforts, identify gaps, and measure long-term progress. Publicly sharing this data can build awareness, encourage participation, and celebrate North Bay's achievements in sustaining one of its most valuable natural assets.

LANDSCAPE

Landscape includes planning, design, construction and maintenance of parks, green spaces and cemeteries suitable for the intended use and location on a year-round basis. Elements for evaluation include native and introduced materials; biodiversity, materials and constructed elements; appropriate integration of hard surfaces and art elements, use of turf and groundcovers. Landscape design should harmonize the interests of all sectors of the community and provide safe and secure public spaces. Standards of execution and maintenance should demonstrate best practices, including quality of naturalization, use of groundcovers and wildflowers along with turf management.

LANDSCAPE

Observations:

North Bay's recent downtown revitalization has given the city centre a fresh, welcoming look. The hardscape design is modern and well executed, making the downtown core highly walkable and inviting. Congratulations on the very successful implementation of this project.

The city is blessed with numerous parks, trails, and cycling pathways, all of which were observed to be well maintained and thoughtfully designed. These green spaces encourage recreation, active



transportation, and community connection, making them an integral part of daily life in North Bay.



The waterfront is the city's signature landscape feature and a true point of pride. It offers a wide variety of amenities — volleyball courts, playgrounds, docks, a marina, water sports access, a boardwalk and pier, fishing areas, and the beloved Kiwanis Bandshell performance space. The Farmers' Market adds vibrancy to the waterfront, creating a lively gathering place where residents and visitors can connect. The Skatepark and Pump Track are standout facilities, uniquely designed to be durable, manicured, and seamlessly integrated into the surrounding landscape. These spaces

offer recreational opportunities for youth and families while maintaining visual harmony with the waterfront environment. Many of these amenities have been made possible through sponsorships and community fundraising efforts, demonstrating North Bay's strong spirit of collaboration and its visionary planning approach. The result is a waterfront that is not only beautiful but also highly functional and accessible for all ages and abilities.

At Sunset Park Public School, teachers have created a truly inspiring outdoor learning space. Their book, The Mighty Gardeners, served as the inspiration for the garden, which features brightly painted stones designed by the students. This initiative not only develops horticultural skills but also nurtures confidence, personality development, and a sense of pride. The garden has become a meaningful part of the school's identity and an excellent example of how landscapes can educate and empower youth.

Residential landscapes across most of the areas we visited were well cared for, with many homes showcasing attractive plantings and neatly maintained yards. This attention to private property upkeep greatly enhances the overall beauty and curb appeal of the community, reflecting the shared pride that was evident throughout North Bay.

Recommendations:

Some of the murals observed in the downtown area showed signs of wear and degradation, which affected their visual appeal. To maintain the quality and longevity of public art, the city could consider developing clear standards for mural creation, installation, and maintenance. These standards could apply to both city-commissioned works and those produced by local businesses or independent artists, ensuring that all installations are properly prepared, protected, and sustainable over time. Establishing these guidelines would help preserve the vibrancy of North Bay's public art and reinforce the city's reputation as a creative and visually engaging community.





The waterfront is a busy and vibrant site, attracting residents and visitors for a wide variety of activities. People access the area on foot, by bike, scooter, skateboard, or rollerblades, making pedestrian safety a top priority. During our visit, we observed a particularly concerning area at the turning corner of Memorial Drive, where the beach footpath opens onto a busy roadway. Pedestrians must cross traffic moving in both directions and navigate a nearby train track to reach the sidewalk by the Homewood Suites hotel.

Consider adding banners and self-watering hanging baskets on streetlights along the promenade. These would guide visitors to key focal points, enhance the pedestrian experience, and reinforce the waterfront as a vibrant hub. Seasonal floral displays or thematic banners could involve local artists and sponsors, bringing colour, movement, and a year-round sense of celebration.

These enhancements would further unify waterfront features, including the Kiwanis Bandshell, Farmers' Market, and Skatepark and Pump Track. By connecting these amenities visually and functionally through landscaping, signage, and decorative elements, the city can create a cohesive, engaging, and safe environment that encourages residents and visitors to explore, gather, and enjoy North Bay's signature waterfront.

PLANT AND FLORAL DISPLAYS

PLANT AND FLORAL DISPLAYS

Observations:

The downtown core features a diverse array of floral displays that enhance its charm and visual appeal. Raised bed planters are used creatively to beautify vacant spaces, and all displays were observed to be well maintained, contributing to a welcoming and vibrant streetscape. Many planters also feature edible plantings, including kale, herbs, and fruiting plants, demonstrating creativity in combining aesthetics with productivity.





The waterfront is a standout feature, offering a kaleidoscope of colour and variety through its floral displays. Congratulations to the North Bay Heritage Gardeners for their dedication in creating and maintaining these displays, which add significant beauty and character to the area, making it an inviting destination for residents and visitors alike.

At Suswin Village, Indigenous plantings such as sweetgrass, sage, beans, and lettuce reflect the local culture and traditional knowledge, providing both a visual and educational connection to the community's Indigenous heritage. These plantings serve as a meaningful reminder of North Bay's commitment to inclusion, diversity, and reconciliation.

The Cappadocia Residence is a remarkable example of integrating edible gardens into private property. The site features a combination of flowers and vegetables, along with a composting station that supports sustainability and resourcefulness. Such initiatives highlight how residents can blend beauty, productivity, and environmental stewardship in their landscapes.

Thank you for participating in this year's Communities in Bloom national theme, Edible Gardens. Many edible plants can be seen in downtown planters, including kale, herbs, and even fruiting plants such as bananas. Creative edible elements were also incorporated into the welcome bouquets in our hotel rooms and the floral displays at lunch at the Deacon's Residence. These thoughtful and imaginative touches demonstrate a wonderful blend of beauty and productivity—well done!



Recommendations:

Outside the revitalized downtown area, business districts could benefit from additional plantings and floral displays to enhance their visual appeal. The Days Inn downtown serves as an excellent example of how businesses can beautify their spaces and inspire others to follow suit. The city could partner with the BIA or Clean, Green, Beautiful North Bay to create a "Best Business Floral Display" contest, providing suggested plant types or colour palettes to create a cohesive look across the community. Businesses would be responsible for maintaining their displays throughout the season and could be recognized through the Streetscapes program, reinforcing civic pride.



There is also an opportunity to diversify plant selections throughout the city to support pollinators, attract wildlife, and create visual interest across all seasons. A layered approach could combine spring bulbs, summer and fall annuals and perennials, winter-interest plants, and ornamental grasses. Beyond traditional flowering annuals, foliage plants like coleus, amaranth, and iresine, as well as edible options such as ornamental kale, Swiss chard, cabbage, potato vine, and culinary herbs like basil, oregano, chive, and sage, could be incorporated to enhance both beauty and ecological value.

When one plant underperforms, it can leave visible gaps that are labour-intensive to replace. Mixing compatible species of similar height and colour within each planting section can create natural texture and depth, reduce maintenance, and allow healthy plants to fill gaps over time. This approach also improves soil health, retains moisture, and increases the overall resiliency of displays against plant loss.



Finally, continued monitoring and management of Japanese beetle populations is recommended. Best practices include hand-picking beetles into soapy water, applying beneficial nematodes seasonally, and protecting natural predators such as the winsome fly (Istocheta aldrichi). Avoiding broad-spectrum insecticides is critical to prevent harm to beneficial insects and maintain ecological balance. Public education campaigns could encourage residents to take part in these efforts and discourage the use of pheromone traps, which can inadvertently draw more beetles into neighbourhoods.
